#### Introductions

- A) Don Delcourt talked about a couple of the updates as of late:
  - ASTTBC Fire Protection Website is being updated. (please send us suggestions!)
  - 2) All Challenge Exams are being updated
- B) The reason for the meeting is to get feedback from the technicians and people in the field. We want to know what's working and what's not. How can we make the program better?
- C) Tags: ASTTBC wants to improve proper tag use guidelines and the way we communicate this to the techs. Compliance department has come across many issues with the tags.

Comment from techs: AHJ say they want things punched out on the tag and it's against what ASTTBC wants. Discussion.

- D) Electrical Work Practitioner: What's the status on this program? It likely won't be offered for at least another year due to some legal matters.
- E) Verification of Fire Alarms is now in 'abeyance' and ASTTBC will not be certifying in this discipline until, at least, end of 2015.
- F) Code Books: Part of membership could include access to Codes and Standards via the website.
- G) A requirement Matrix will be available soon via the website. This would include things like Codes and Standards, forms and tools.
- H) Electronic Stamps: (By show of hands) The majority of techs at the meeting were in favor of an electronic stamp.
- Questions and discussion surrounding 120V testing. Unless you are a ticketed electrician you can only unplug and check the E-Lights. Don't start messing with the wires. Don't touch above 120V.

It could be narrowed down to each company but even then it's not guaranteed to make it to everyone. - L) Discussion surrounding Water-Based Fire Protection Systems Clarity needed Chloramine/Chlorine?
- M) Logbooks: This is a requirement. Technicians are required to keep a log of the work they do.
- N) Stamps: Each technician is to have ONE stamp only.
- O) FAQ on the website Erin and Bob are creating an FAQ section on the website.
- P) Auditing Program: most of the techs were in favor of an auditing program.
